Narrative:

On 11 FEB 2014 at approximately 1515 hours, Sergeant Denizot and myself were dispatched to Alan Chapman Activity Center to meet with a student who reported being raped. I arrived at approximately 1515 hours, made contact with student, victim Abby Ross (TU ID:). Ms. Ross informed me that she was raped on 27 JAN 2014 at approximately 2130 hours, in Lorton Village Apartments #4033 where student, suspect Patrick Swilling (TU ID:) resided. Ms. Ross stated that she only knew Mr. Swilling as an acquaintance of the basketball team, that she had not been to his apartment prior to the incident; Mr. Swilling had asked her to come "hang out" but she had previously declined.



Ms. Ross stated that when she agreed to go to his apartment, she made it clear that she was there to watch the Oklahoma Sooner Basketball game; not to be a "booty call". Ms. Ross informed me that while they were watching the game in his bedroom, Mr. Swilling grabbed her rear end; she then moved away from him toward the bedroom door. Ms. Ross stated that her movement was not enough to keep Mr. Swilling back, he pursued her refused to comply with her verbal commands to "Stop". Mr. Swilling followed her to where she was standing; in the door way of his bedroom, pulled her pants down then penetrated his fingers into her vagina. Ms. Ross stated that she continued to command Mr. Swilling to "Stop", Mr. Swilling told her to "Shut up", flipped her over and started to penetrate her vaginally with his genitalia. Ms. Ross stated at this time she began to cry, continuously instructing him to "Stop", while he continued to tell her to "Shut Up". Ms. Ross stated that after Mr. Swilling was "finished", he went into his bathroom to wash up. He allowed her to leave after he stated, "no one is going to know about this right?". I asked Ms. Ross if she had any bruises or markings on her from the incident, she stated that she did not. I asked Ms. Ross if she had further contact with Mr. Swilling after the incident, she stated that he had recently sent her text messages (see pictures).

I asked Ms. Ross if she filed a report with the Tulsa Police Department, if so the number of the report, she stated she filed one on 11 FEB 2014, with Tulsa Police Officer Eric Leverington (2014-008279). I asked Ms. Ross if she sought out medical attention, she stated that she went to a local hospital where they did a Sexual Assault Forensic Evidence Kit (SAFE), on 28 JAN 2014. I also asked Ms. Ross if Mr. Swilling or herself had been drinking that evening, she stated they were not. Ms. Ross did inform me that she told a few of her friends of the incident but thought "these individuals would not say anything". After Ms. Ross left campus, I called and asked which hospital she went to, she stated Hilcrest Hospital was where she went. Any further questions I tried to ask in regards to her statement she was uncooperative, stating "she did not want to continue to relive the incident."
