Upon my arrival, I made contact with the Registered Nurse Cindy Allen. Allen stated that she completed a Sexual Assault Examination on [redacted] Allen sealed and signed the kit and I then signed the kit as received on 10-16-2008 at 1800 hours. Allen gave me a copy of the Missouri Department of Health and Senior Services, Adult Female Sexual Assault Exam, which was attached to this report, and a copy was given to Sergeant Spalding. The Sexual Assault Kit was later placed into evidence at MUPD.

[redacted] left the building prior to my arrival. I asked Allen if [redacted] wanted contact from law enforcement to initiate a report. Allen stated, that she was upset today and that we could probably contact her tomorrow. Allen did not say that [redacted] did or did not want contact from law enforcement.

Allen stated that [redacted] told her that she knows the suspect; however, Allen did not obtain the suspect's name.

See MDHSS, Adult Female Sexual Assault Exam report, prepared by Allen for further.

I was able to make contact with [redacted] at approximately 2100 hours. At this time [redacted] stated that she did not wish to make a police report.

Major Schwandt was notified of the incident per directive.

On 10/22/08, at approximately 1245 hours, I, Detective Sam Easley, contacted [redacted] at the University of Missouri Police Department, in reference to this case. I escorted [redacted] to Interview Room A, and she stated she wanted to speak with me about an incident that happened to her on 10/12/08. It should be noted that I had spoken to [redacted] via telephone the day before, and she stated she had been in contact with representatives from the Women's Shelter and Women's Center on the University of Missouri Campus. [redacted] stated to me on the phone that she had been raped, and thought she should come to the University of Missouri Police Department to meet with me and talk about the incident.

I asked [redacted] to start by explaining to me the events that happened that day leading up to the incident. [redacted] stated on the morning of 10/11/08, she received a text message from a subject by the name of Derrick Washington. [redacted] stated Washington is a football player for the University of Missouri. [redacted] stated she met Washington last year when they were both freshman and she met him at a friend's residence. [redacted] stated at that time, she was left alone with Washington and the first words he spoke to her was "how bout a blow job?" [redacted] stated she was instantly insulted by Washington's comment and then left shortly after. [redacted] stated over the next several months she was contacted by Washington, and he told her that he had never had a girl say no to him and he was intrigued by her and wanted to hang out with her. [redacted] stated over time her and Washington became friends and talked through the phone, internet, and texting.

[redacted] stated on 10/11/08, she received a text from Washington around 0900 hours and asked her how she was doing. [redacted] stated she texted him and asked him where he was at and he stated he was at the hotel, because they have to be at the hotel before the game. [redacted] stated Washington asked her to send him a picture of her to his phone and she stated she could not take a picture on her phone. [redacted] stated she then asked Washington to send her a picture of him on his phone and he did. [redacted] stated the picture was a picture of Washington's face when he was in his hotel room.

[redacted] stated Washington asked her if she wanted to kick it after the game and she stated she had to work and could not hang out after the game. [redacted] stated Washington told her "okay, we need to kick it sometime." [redacted] stated she got ill during the rest of the day and she texted Washington and told him she was not going to go to work because she was sick. [redacted] stated Washington told her "okay, I will call you after the game." [redacted] stated she had severe sinus problems and was sick to her stomach that day. [redacted] stated that afternoon she went to a friend's house on Bearfield and hung out there for a while. [redacted] stated she then went to another friend's house at the "J-Slums." The "J-Slums" is an apartment complex located almost directly across from the Journalism School on Ninth Street. [redacted] stated at both friend's houses she told multiple people that Washington was coming over to her room after the game was over. [redacted] stated while she was at the J-Slums, she consumed alcohol that her friends called "Lifeguard Lemonade." [redacted] stated she was not sure exactly what kind of alcohol was in the mixture, but she stated it was clear alcohol, possibly Sprite and Vodka. [redacted] stated she had two cups of the alcohol, but she stopped because the mixture was bothering her sinus problems.

At this time [redacted] stated she was still not feeling well so she left the party and went back to her residence hall, [redacted] stated she thought she went to Bearfield at approximately 1800 hours, and stayed there until halftime. [redacted] stated she then went to her room for a little bit because she was not feeling well and listened to the game on the radio. [redacted] stated she called her friend [redacted] and invited her over to the "J-Slums" to watch the game. [redacted] stated she left her room when there was an interception with approximately 2:17 left in the game.

stated she went to the "J-Slums" around 2230 hours, and she left between 2330 and 0000 hours. stated she went back to her room and got into her pajamas and went to sleep. stated she was wearing black girl's gym shorts and black Mizzou t-shirt. stated she was not wearing any underwear or a bra because she had not done any laundry yet. stated she went to bed and her friend texted her and told her there was a party at her house and she needed to get there. stated this was about 0130 or 0200 hours on 10/12/08. stated after she received a text from her friend she got a text from Washington asking if he could come over. stated she told Washington that she was in bed in her pajamas and was not feeling well. stated Washington texted her back and said "okay, I am on my way over now."

stated that after she heard from Washington, her friend Jimmy called her and was telling her about another party. stated she told her friend Jimmy that Washington was coming over and she said Jimmy told her to tell Washington that he sucked in the game. stated she told Jimmy that she was not going to tell Washington that and she hung up the phone. stated after she hung up the phone Washington called her and asked her to come down and let him in the residence hall. stated it was about 0200 hours in the morning and she went to let him in, but he was already inside in the lobby. stated they went up to her room and she asked him if he wanted anything to eat, drink, or if he wanted gum. stated Washington asked for gum so she gave him some gum.

stated her and Washington both sat down on her bed and started talking about the game. At this point in time stated the lamps in the room were dim. stated Washington told her "you know when I first met you, you were a small town girl and now you are a stripper." stated she told Washington, "yeah, I know but I still have the same good values." stated they then both laid down and started cuddling with each other. stated they started kissing each other and still had their clothes on at this point. stated Washington suggested she take her clothes off to get more comfortable and she stated "that puts me in a compromising position." stated she told Washington "well your clothes are not off, why don't you get more comfortable." stated she admitted being a little star struck of Washington and stated it was like having a celebrity in her room.

stated Washington took his shirt off and she told him "sex is for marriage, it does not matter what I do I still have morals. stated Washington stated "yeah, I agree." stated she told Washington she did not want him to put his penis inside of her. stated they began kissing each other, and while they were making out her shirt came off. stated she was not sure if Washington took her shirt off or if it was her. stated Washington began kissing her breasts, neck, lips, and ears. stated Washington bit her neck and left a painful hickie on her neck. stated when Washington was giving her the hickie she pushed his head away and she turned her neck. stated she and Washington were on the bottom bunk and her roommate was not there at the time. stated Washington was on top of her for a little while when they were kissing.

stated Washington told her "you know if we are not going to have sex, why don't you give me some oral sex?" stated she told him she really did not want to and he stated "C'mon please, at least do that." stated she then performed oral sex on Washington and he took his pants off before this occurred. stated Washington took his pants off and laid in the bed while was performing oral sex on him. stated she gave him oral sex for about five to ten minutes. stated Washington "is really well endowed" and it actually hurt her mouth so she stopped. stated she then got up and put her shirt back on and Washington took her shirt off again. stated Washington got up from the bed and sat down in her roommate's chair while was standing in front of him. stated Washington pulled her down onto his lap, and said how about you give me a lap dance; that is your job. stated she told Washington she was not working and not to say those types of things.

stated at this time she was facing forward and her shirt was off. stated Washington asked her again to give him a lap dance and said "c'mon just a little one." stated she then performed a "sarcastic silly dance", that was not seductive in any way. stated she sat down on his lap and put her chest in his face and was laughing at the time. stated she jumped off of him and then went and laid down in bed and said she wanted to cuddle. stated Washington had three to four layers of underwear, shorts, and pants on and she does not know if his clothes were off at this point or not. stated Washington got into bed with her and stated "hey, you will be more comfortable if you took your pants off." stated she told Washington that she would be in a very compromising position and he had to promise her that if he took his pants off he would not put himself inside her. stated Washington told her "yeah, I understand your morals and you are a good person." stated she then told Washington "okay, as long as you promise me." stated Washington is a very persistent person and she is ashamed she put herself in that position.

stated she was laying on her back and Washington was laying on his side. stated Washington used two fingers of his left hand and tried to put one finger in her anus and the other in her vagina. stated she stopped Washington from putting the finger in her anus and she told him she did not like that. stated Washington then began to digitally penetrate her vagina for approximately five to ten minutes. stated as Washington was penetrating her vagina with his fingers, he was making statements like "you are really wet, and you really like that don't you."

stated everything up to this point was done consensual and while Washington was fingering her she climaxed by "squirting." stated she made Washington promise three times not to put his penis inside of her. stated Washington told her "wow, you are a squirter, that is really hot." stated the next thing she knew Washington was on top of her and she said what are you doing. stated she tried to push Washington off of her because she was realizing that he was trying to put his penis inside her. stated she told Washington "don't do that" and he did not say anything. stated she continue saying "don't do this, don't put yourself inside of me", and she was putting pressure on his chest with her palms and was saying no. stated she felt Washington put himself inside of her and she stated "stop that what are you doing." stated Washington then began threading her palms off his chest with his arms, and he used his forearms and shoulders to pin her down. stated she did not look at Washington's face during the incident and she curled her hands up in a fist and started hitting him. stated Washington used his chest, shoulders, and forearms to pin her down and hold her arms down.

stated at this point she was screaming and crying saying "stop, stop, please stop." stated Washington was thrusting and it hurt a lot because he is large. stated the incident felt like it lasted a long time, but in reality it probably only lasted about two to five minutes. stated she was saying "get the fuck off", and hit the sobbing stage and stopped fighting. stated as she was sobbing Washington stopped, and according to "snapped out of it" and said "oh my god what am I doing, what am I doing, I am so sorry, this did not just happen." stated Washington told her "please stop crying, please stop crying."

stated when Washington got off her she moved toward the wall as far away from Washington as she could and she looked over at him and he had his face in a pillow and appeared to be crying. stated Washington said "Oh my god, what just happened." stated she kept crying and Washington stated "you make me want to kill myself." stated Washington told her he wanted to kill himself about five times and stated just stop crying about five to seven times. stated Washington then stood up and stated "oh my god, this did not just happen." stated Washington began pacing back and forth in the room and stated she was still crying. Washington then stated "you make me want to kill myself" and she began to cry more. stated she then told Washington it would be okay and they would just forget this happened. stated Washington then sat down beside her and she said you promised me you would not put yourself inside of me and Washington stated "I know, I just

lost it." stated Washington told her "I know I fucked up and I'm sorry." stated she told Washington "you lied to me" and he said "you are too pretty to cry."

stated Washington then stood up and put his clothes on and she put her clothes on as well. stated Washington told her he thought he had better go and she was walking him out of her room when he turned and said "it is not like it matters, or you are a virgin." stated Washington told her "I don't know why you are so upset." stated she walked Washington outside and she was still sobbing when Washington stated "I'm sorry, I'll treat you right, we'll go on a date." stated Washington then left and he called her on his way home and told her he did not want her to cry. Washington told her he would text her in the morning.

stated she then went back inside and went up to her room and went to bed. stated she got up around 1100 hours the following morning. stated Washington texted her around 1400 hours and said "hey." stated she went to the ceramics lab the next day and to work, and then came back and went to AT&T to get a new phone. stated she texted Washington and told him she got a new I-Phone and he said why don't you get me one. stated she told Washington "I am not your sugar momma" and Washington replied by saying "well you could be." stated a couple of days went by and she tried to forget about the incident and she went to get her nails done. stated when she went to the nail salon her ex-boyfriend was there and he is stated her ex-boyfriends name is and they hung out together after she got her nails done. stated while they were hanging out together stated started talking about volunteering at the and he wanted to show her a choke move to show her how she could get someone off her. stated when this happened she broke down and told what happened with Washington. stated told her there was several options about what she could do about the incident. told her she could go to the police, talk to a lawyer, or go to the football coaches and tell them what happened. stated told her if she went to the coaches she would have to have proof of what happened and they would make her sign a contract saying she would not talk about the incident. stated told her in return for her silence she would possibly get a full ride scholarship or something of that nature. stated told her he had seen that type of thing happen before.

stated she also talked to a lawyer friend of hers by the name of ; stated she showed several text messages that Washington had sent to her and looked them over. stated got back with her and told her based on the text messages, she did not have a strong case, but he would try to speak with the attorney for the football team and talk with him about it because they know each other.

stated she went to the Student Health Center because she had an ingrown hair that she thought was an STD. stated at the student health center they asked her questions and asked what was wrong with her and she stated she got raped. stated she went home for a few days to try and forget about what happened. At this time I asked to tell me how many people she had told about the incident and she stated she told the bouncer at where she is employed. stated the bouncer's name is also stated she told her friend's and , the owner of and the bartender at that goes by the name of

I then asked to tell me again what happened when she told about the incident. stated she and dated quite some time ago and that day he was trying to show her a choke hold and he made her do the choke hold on him and it was not working out well. stated she then broke down and told that she was not feeling that well on the night of 10/11/08 and into the hours of 10/12/08, and Washington came over and they started kissing and then he started putting himself inside her.

stated just sat there and she told him she just wanted to forget about it. stated replied by saying "I am tired of these fucking niggers trying to do this to girls, and it makes it tough on other team members who actually want to treat women nicely, and it gives them a bad rap." stated she told that if she turned this

in it was going to be detrimental to the football team. stated told her there were three things she could do. told she could go to the police, go to the coaches, or just do nothing. stated she told that she did not want to destroy this kid's life, and if she took football away from him he would have no reason to live. told her if she went to the coaches she was going to need an audio recording of what he did. stated told her "you are a stripper supporting your way through college and that nigger is a football player and he lives the good life." told her that coaches might make her sign a contract to make sure she would not say anything and she might get a full ride scholarship.

At this time I asked if she had sexual intercourse with anyone after the incident happened with Washington. paused for a moment and then lowered her head and said she did have sex with earlier on a Tuesday possibly 10/14/08. stated she had not wanted to talk to and had not talked to him in several weeks until she went into his store and saw him. stated at approximately 1900 hours that night she went with to Shakespear's to eat dinner and then they went to his house and had sex before she told him about what happened to her with Washington.

stated she and were sitting around talking about the incident and told her if she felt more comfortable she could get their friend advice. stated is an attorney in Columbia. stated she called office and spoke with his paralegal on Wednesday. stated she was able to get in touch with and told him the story. stated told her he was good friends with coach Pinkle's lawyer and he would read over the text messages that Washington sent her after the incident. stated suggested she get Washington to come over and record him talking about the incident. stated she suggested texting him to illicit a response.

At this time I asked if she had sexual intercourse within the last forty eight hours prior to the assault and she stated no. I asked if she had ever had a Sexually Transmitted Disease and she stated no. I asked if she had consumed alcohol prior to the assault and she stated "yes, two cups around 2230 or 2300 hours." I asked if has been taking any medication and she stated no. I asked if she was under the influence of any drugs at the time or prior to the incident and she stated no.

I asked if Washington forced or tricked her into taking any drugs or alcohol and she stated no. I asked if ejaculation occurred and she stated no. I asked if she bathed, douched, or cleaned up before the hospital exam and she stated "I don't think so." I then asked what abnormal sex acts occurred during the incident and she stated oral sex and that was consensual. stated she would email me the text messages she received from Washington so that I may read them and put them into evidence. As this time was escorted out of the building. It should be noted that approximately two times during this interview, paused and began to tear up as she was speaking about the incident.

On 10/24/08, at approximately 0820 hours, I, Detective Sam Easley, contacted Derrick Washington at his residence of 202 Nikki Way, Columbia Mo. Washington agreed to ride with me to the University of Missouri Police Department to talk about this incident. When we arrived at the University of Missouri Police Department I escorted Washington to interview Room A and I read him his Miranda Warning, which he stated he understood. I also provided Washington a Miranda Rights Waiver Form which he stated he read and signed. I also asked Washington if he wanted a glass of water and he stated he did not.

At this time I asked Washington if he knew the reason why I was speaking with him and he stated no. I explained to Washington that I was inquiring about an incident that happened between him and a female on the night of the Oklahoma State football game on 10/11/08. I asked Washington if he knew about the incident I was talking to him about and he stated "talking about a girl named [redacted] I think." Washington stated "she came at me on Facebook talking about she wanted to hang out." Washington stated when he went over to [redacted] room, she got naked and "gave me some head." Washington stated he put it in and she said stop and he stopped and got up and left.

I then asked Washington to begin by telling me what happened starting with that morning prior to the football game. Washington stated on the morning of the football game he and [redacted] were texting back and forth to each other. Washington stated he found out [redacted] was a stripper through a text that morning. Washington stated [redacted] started texting him the night before and told him she was at work. Washington stated on that night she told him what she does for a living. Washington stated [redacted] stated she was a dancer at [redacted] and a lot has changed over the years. Washington stated [redacted] asked him what he was doing after the game and if there were any parties and he asked her the same thing.

Washington stated he had meetings that morning of the football game and the next time he and [redacted] communicated with each other was after the game. Washington stated [redacted] texted him after the game and told him she did not have to work and was at some party. Washington stated [redacted] asked him "when are we going to kick it?" Washington stated he told her "I don't know whenever." Washington stated he was at a friend's house and she texted him again and asked him to come over. Washington stated he texted [redacted] back and asked her where she was at. Washington stated he was at a friend's house near where his residence is. Washington stated he drove over to [redacted] residence hall and parked in front of [redacted]. Washington stated it was around 0100 and 0200 hours on 10/12/08. Washington stated he was going to [redacted] room in [redacted] and he called her and told her he was downstairs. Washington stated [redacted] came downstairs and let him inside and then she walked him back to her room.

Washington stated he and [redacted] began talking in her room and were talking for about five minutes. Washington stated he went and laid on the bed on the bottom bed of bunk beds. Washington stated [redacted] came over and laid on the bed with him. Washington stated at this time clothes came off and he took her shirt off and he cannot remember if she had a bra on or not. Washington stated [redacted] took her pants off eventually and he took his shirt off. Washington stated he was laying on the bed and she got on top of him and straddled him. Washington stated [redacted] started kissing him and teasing him. [redacted] told Washington she is a good teaser and she began kissing his chest, stomach, and pelvic area. Washington stated [redacted] pulled his pants down a little bit and was kissing his upper groin area. Washington stated he then said "It's my turn now and he started kissing her and got on top of her and was kissing her stomach, chest, and neck. Washington stated he thought [redacted] mentioned something to him about giving her a hickie. Washington stated as he laid on the bed he started playing with [redacted] chest and nipples and

she told him that she "squirts." Washington stated he told "I have never seen that before, show me."
Washington stated at this time both of their pants were off and he does not remember when they came off.

At this time Washington stated he started playing with vagina with his fingers inside and outside of her vagina. Washington stated told him that the finger stimulation would not work and she then grabbed his penis and started hitting his penis on her vagina. Washington stated he cannot remember which hand she grabbed his penis with and Washington stated his penis was fully erect at this time. Washington stated he does not know how many times hit his penis on her vagina but that her vagina was extremely lubricated. Washington stated told him to digitally penetrate her vagina and when he did that she had an orgasm "all over the bed."

Washington stated he penetrated the vagina with two fingers and he did not try to penetrate her anus with his fingers. Washington stated he digitally penetrated her vagina for approximately two minutes and he assumed she climaxed because her legs got stiff and she "was shaking and stuff." Washington stated the first time climaxed, he observed squirting and she soaked the sheets. Washington stated after he saw "squirt" the first time he asked her if she could do that again and she stated she could if he digitally penetrated her vagina a second time. Washington stated he began to digitally penetrate her vagina with his fingers again and she climaxed a second time by squirting as well. Washington stated he was on top of at this point and she started rubbing his penis against her vagina and he noticed it was very lubricated.

Washington stated at this time he put his penis inside of her and was having sexual intercourse approximately thirty seconds before told him to stop. Washington stated he was not wearing a condom and stated did not mention anything to him about putting his penis inside of her. Washington stated while they were having sexual intercourse and told him to stop, he took his penis out real quick and she started crying. Washington stated did not scream, yell, or punch at him during the incident and she did have tears coming down her face. Washington stated talked to him about not having sex when the kissing started. Washington stated told him she did not want to have sex and he responded to her saying "I don't want to either." Washington stated told him not to have sex with her maybe three times but he cannot understand how she could say that because she "put my stuff right next to her and she does not want to do something."

Washington stated he asked what she was crying for and told her she did not need to be crying. Washington stated said "you tried to have sex with me and you did not have a condom on." Washington stated he apologized to and stated "I'm sorry, that was not my intention when I was doing that." Washington stated when he apologized to she did not say anything. Washington stated she cried for approximately one minute and then they got up and talked. Washington stated he asked where she kept all her money at and she stated "you will never know where I keep my tips." Washington stated they then walked downstairs and was not crying when she was escorting Washington out of the building.

Washington stated when he left he called and asked her if she was alright and he told her he would talk to her tomorrow. Washington stated he thought probably went to bed after he called her. Washington stated the next day texted him and asked him if he was clean and why he did that to her. Washington stated the incident should not have happened and stated [redacted] told him she was okay and they are friends and they would leave it at that. Washington stated he thinks he did not do anything wrong and she told him to stop once and he did. At this time I asked Washington if he ever mentioned killing himself that night and he stated "hell no, I did not say anything like I wanna kill myself." Washington stated he said, "I'm sorry, that was not supposed to happen."

At this time I asked Washington how long he had known [redacted] and he stated he met her last year at the beginning of school and his friend was going over to her room to see her roommate. Washington stated [redacted] wrote him [redacted] and she asked him if he still remembered her and how she has changed a lot over the past year.
